Tony is also involved in the revitalization of a large brownfield site located along Sterling Road in west Toronto, and has provided evidence at the Ontario Municipal Board in support of this redevelopment.

Tony has played an active role in a number of transit planning projects. He was the planner for the City of Waterloo Station Area Planning Study, assisting in the development of a contemporary planning framework to align new growth with the future LRT stations. Tony was previously involved in the Davenport Community Rail Project and Environmental Assessment, and worked as a planner for the Meadowvale GO Station Master Plan.
