# MINNESOTA MAYORS TOGETHER

## MN MAYORS TOGETHER KICKOFF MEETING IN BEMIDJI

#### **RCM Executive Committee**

- On October 11-12, 2017, thirteen mayors, including five members of the Regional Council of Mayors, gathered in Bemidji, MN for the first of a series of conversations across the state. This initiative is aimed at breaking down the urban/rural divide by bringing Minnesota mayors together in conversation to build trust. Its purpose is to shift a negative culture, not to build a structure.
- RCM participants included Mayors Hovland, Cummings, Spano, McGuire and Kautz.
- This first meeting included a roundtable discussion about the challenges facing each city and revealed many similarities and some differences. It was a first step in achieving the goal of developing relationships and establishing trust among metro and Greater Minnesota mayors



- A common issue observed is the importance of a trained and available workforce. Many Greater Minnesota cities are
  more reliant on the success of a major employer to sustain and grow their local economy and tend to need State
  bonding to support economic development projects.
- Minnesota Mayors Together can lead the way in establishing a more collegial dialogue that can translate to effective
  governance at the State level and mayors can be an important driver to hold legislators accountable for the effect of
  parochial decisions on other cities in the metro and across Greater Minnesota.
- Three to four more Greater Minnesota visits will be scheduled in 2018. The next dialogue will take place February 8-9, 2018 in Duluth. It is envisioned that the original RCM participants will continue to attend future meetings and at least one of the Greater Minnesota Mayors will be the same as in Bemidji.

#### **BRIDGING THE URBAN-RURAL DIVIDE**

## Darin Broton, Tunheim

- Whether they live in Greater Minnesota or the Metro Area, too many Minnesotans feel that their neighbors throughout the state do not share the same values and priorities as their families. The politics of division fuels animosity between communities, and elected officials in St. Paul and Washington have found ways to use this animosity for their own benefit
- Minnesota mayors can change this narrative by cultivating new relationships and listening to each other. Everyone shares the values of hard work, self-reliance and resilience. We are all community-centric and rely on each other when times are tough.
- Minnesota mayors are committed to bridging the urban-rural divide by building stronger relationships. Changing the
  narrative is bigger than public policy changes or collaboration; it is standing up for and supporting communities half
  way across the state.

- From the visit to Bemidji in October, it was observed that northwest Minnesota cities feel disconnected and must look out for themselves with regard to state legislative issues and funding.
- The platform of Minnesota Mayors Together can help to bridge the urban-rural divide and is based on the nexus between relationships and values. How do we collaborate to build a stronger relationship for the benefit of the entire state?

#### THE URBAN-RURAL DIVIDE

#### Matt Schmitt and Dane Smith, Growth and Justice

#### **PRESENTATION**

- Growth and Justice are encouraged by the Minnesota Mayors Together initiative and believe the collaboration will pay dividends on a long-term basis.
- Data indicate that there are many common issues across the metro area and Greater Minnesota. The most prevalent issues of common ground include school funding, transportation, Local Government Aid, water quality and immigration.
- Diversity in our population is a characteristic of both the metro area and Greater Minnesota cities. In fact, data
  indicates that there is a higher rate of increasing diversity in Greater Minnesota than in the metro area which has
  fueled a high rate of entrepreneurial businesses as many of these entrepreneurs are from immigrant populations.
- Based upon the data, there is a high level of interdependence between metro and rural communities. Minnesota Mayors Together is an opportunity to build on this interdependency.
- Growth and Justice has observed that regional parochialism is damaging across the state. Minnesota Mayors
  Together can help to emphasize what brings communities together, rather than what divides us.

#### Dave Unmacht and Kevin Frazell, League of Minnesota Cities

- LMC is appreciative of being included within the Minnesota Mayors Together initiative and is committed to continuing
  to offer assistance and be engaged in future discussions and activities. Bridging urban and rural interests has long
  been a priority of LMC.

- The "Mayors Challenge" provides an opportunity for cities to participate in the effort to end veteran homelessness in Minnesota.

- The Challenge is effective Veteran homelessness declined 47% in participating cities over a two-year period from 2014 to 2016.

## **URBANPLAN FOR PUBLIC OFFICIALS**

- UrbanPlan for Public Officials (UP4PO) launched in Minnesota on October 13 in Edina. It was attended by about sixty
  people including elected and appointed officials, staff and community members and was described as a terrific
  experience by Mayor Hovland.
- UP4PO is modeled after the program offered by ULI MN in high schools. It presents a real-world development
  challenge and asks participants to step into the shoes of developers who respond to a hypothetical request for
  proposal issued by a fictitious city. It culminates with presentations by participants to ULI MN real estate professionals
  who play the role of a city council.

## TAX REFORM LEGISLATION, MARGARET KAPLAN, MINNESOTA HOUSING

- The tax reform bill under consideration in Congress, among other things, eliminates tax exempt private activity bonds which is a critical financing tool to support affordable housing projects. The repeal of this tool would have devastating effects on the nation's affordable housing and if adopted as proposed would risk the completion of a minimum of 12 affordable housing projects that have been approved in both the metropolitan area and Greater Minnesota.
- In addition to affordable housing, private activity bonds help to finance infrastructure and non-profit projects such as hospitals.
- The Builder's Association has outlined how the proposed tax reform bill would impact homeowners as well. BATC's letter outlining their position can be <u>reviewed here</u>.
