Who was Jeffrey Kahan?

Jeffrey was a principal and director of the Investment Services group of Colliers International in Chicago. He passed away in June, 2012. Jeffrey worked with many institutional and individual clients, helping them to buy and sell real estate, and was highly regarded by his colleagues and clients. Jeffrey was also active in ULI as a member of the Industrial and Office Park Council (IOPC). Jeffrey deeply believed in the value of the relationships formed and information shared through ULI. The Fellowship is designed to pass along his legacy to new leaders in the industry.
