Sadu is a bestselling children's author, whose books are translated into foreign languages, adopted by schools for curriculum and adapted to film.

She is the co-owner of A Different Booklist, one of the few independent bookstores left in Toronto with a focus on finding literary gems that reflect Toronto, the African Canadian and Caribbean Canadian diversity.

Her love for storytelling has taken her to schools around the world where she has developed stories that have a special appeal for children.

A former Vice-President of the Black Business and Professional Association, and former board member of the Canadian Book Centre. Itah is currently a Harry Jerome Scholarship Trustee and a board member of The Watah School, an organization dedicated to the development of the performing arts.

Her awards include: The Onyx lions Award for Community Service, The Elementary Teachers Federation of Ontario Award for Children's literature, Sesheme Hero Amongst Us, Black Business and Professional Association, Women of Honour Award, Toronto Arts Council Foundation Award, the African Canadian Achievement Award for Excellence in Business, Pioneer for Change Award for Excellence in Entrepreneurship, African Canadian Achievement Award for Community Service, and the North York Urban Hero Award for business.



**Angela Simmonds** Manager of Equity and Access Nova Scotia Barristers' Society

Angela believes that education and the law can be used as a tool to address anti-black racism and barriers impacting individuals most vulnerable to structural, systemic inequalities in our society.

Angela Simmonds is the Managing Lawyer of Equity & Access at the Nova Scotia Barristers' Society, the regulator of the legal profession in the province where she is responsible for managing initiatives that promote cultural competence, equity, diversity and inclusion in the profession and access to legal services. She also consultants and provides strategic advice on such matters to organizations, committees, Government, and communities. She previously worked for Nova Scotia Legal Aid, Federal Prosecution Service Canada, Department of Natural Resources, and the Halifax Regional School Board.

Angela has been able to use her legal knowledge, community background and grass roots approach to address racial inequities; discriminatory policies and practices within this province. Angela has presented twice for the United Nations advocating for African Nova Scotian

communities in the area of justice, health, anti-black racism, and land claims. For this work in 2017 Angela was the recipient of the Judge Sparks award, and Burnley "Rocky" Jones Human Rights Award and 2018 Canadian Association of Black Lawyers "Pathfinder" award. She has recently been acknowledged as one of the top 100 most accomplished African Canadian Black woman in Canada in 2020.

Angela also was nominated and named the Vice Chair of the 2018-2019 Electoral Boundaries Commission.

Angela lives in North Preston with her husband Dean of 23 years, they have three children and a grandson.

A highly accomplished Architect, Camille brings several years of experience on award-winning projects, garnering recognition for this work through speaking, mentorship, and teaching opportunities. She excels at liaising with end users and client groups, seamlessly integrating the expertise of consultants, and furthering the design of intelligent and reliable places for natural interaction and individual refection.

Camille believes that it is extremely important for underrepresented groups to be involved with the design of their built environments.
