# **Indian Act & Land Use Management Challenges**



### **Agricultural Development**

The Indian Act enabled the government to lease out Indigenous land to non-Indigenous peoples for farming.

### **Denied Women Status**

As matriarchs are essential in passing down knowledge and tradition, denying women status forced further assimilation.

#### **Creation of Reserves**

The creation of reserves while restricting mobility for Indigenous peoples to move off reserve or into sub/urban spaces.

#### **Residential Schools**

Attendance in Residential Schools became mandatory for children with status regardless of consent from the family.



# **CURRENT LEGISLATION**

#### UN Declaration on the Rights of Indigenous Peoples

Adopted by the general assembly in 2007 to provide a universal framework to reconciliation across the world and elaborates on existing human rights and freedoms. Truth and Reconciliation Commission: 94 Calls to Action Passed in 2015, the TRC provides 94 actionable policy recommendations to address the intergenerational impacts of Residential schools and systemic

violence towards Indigenous peoples.

#### Declaration on the Rights of Indigenous Peoples Act

Passed in 2019, implements UNDRIP as the Province's framework to reconciliation. Requires the Provincial government to ensure that laws are consistent with UNDRIP.
