The non-profit was started in 1987 and currently owns more than 2,400 units in Indianapolis, South Bend and Gary, IN.

The Development Associate position is a newly created, entry level position that will provide strong administrative support to the development team's project funding process. The Development Associate will be act as team lead for the financing application and finance closing diligence while working with the rest of the development team to assess and shape acquisition and organizational strategy to meet MAHCs long term goals and success.

Essential Functions:

- Manage assigned pre-development activities including acquisition, environmental review, project concept development, budgeting, cost analysis and financing of affordable and market rate rental projects
- Complete and update project proformas using a mix of funding sources, including but not limited to, Federal and State Low Income Housing Tax Credits, Federal and State Historic Tax Credits and New Market Tax Credits, Tax Increment Financing and Tax Abatement, and Conventional Financing
- Prepare overall project time lines and schedules
- Compile and assist with writing and packaging finance applications for Low Income Housing Tax Credits, Federal Home Loan Bank AHP, HOME, CDBG and and other grant funds in multiple markets for MAHC and other firms
- Maintain and collect finance closing due diligence from various stakeholders
- Develop and maintain relationships with diverse stakeholders, including private lending institutions, state, federal and local officials, and private equity investors
- Assist MAHC's Services Director in creating development specific tenant-based services
- Provide project assistance for outside MAHC clients
- Assist with database organization

Optional Desired Functions:

- Knowledge of Low-Income Housing Tax Credits
- Strong skills in Excel and proforma modeling
- Understanding or strong interest in supportive housing and service-based developments
