This position is primarily focused on the placement of debt and/or equity for commercial real estate transactions. Analysts have the opportunity to be involved in every stage of a transaction, including underwriting and sizing loans, market research, preparation of offering memorandums, marketing and term sheet negotiation, gathering and organizing due diligence, loan closing, as well as attending client meetings and events.

Analysts will also be responsible for a myriad of support functions, including managing annual reporting for our servicing portfolio, pipeline reporting, and social media engagement. This role will be challenging and rewarding, and the Analyst should be able to manage several competing priorities and engage in multiple transactions simultaneously. The position demands a high level of customer service and excellent communication skills, both written and verbal.

## **Main Responsibilities**

- Underwrite property cashflows to develop financing recommendations for presentation to the Producer and client.
- Prepare comprehensive debt and/or equity offering memorandums for commercial real estate transactions, including research, financial modeling and composition of executive summaries.
- Manage the due diligence process and be the driving force/primary point of contact in working through the closing processes for each transaction.
- Assist in coordinating and reviewing third party reports such as appraisals, market studies, and engineering reports to as part of the due diligence process.

- Manage annual reporting and compliance for the loan servicing portfolio. Assist with collection of
  property operating statements, rent rolls, STR reports, borrower/guarantor financial statements,
  review and analyze financial covenants, trigger events, and DSCR/DY tests. Analyst will be the primary
  point of contact for both borrowers and lenders, performing annual site inspections and property level
  analysis for reporting to Servicing partners.
- Responsible for complex financial modeling of commercial real estate transactions, including Property Valuation, Recapitalization Analysis, Refinance vs. Sale Analysis, Sale/Lease-back Analysis, and Loan Modification & Discounted Payoff Negotiation
