

WHO CAN JOIN

1. Competition is open to any group composed of 3 to 5 women, at least 18 years of age as of September 2022. No restriction is given on the country of origin or citizenship of any team member.
2. Each team must properly declare the profession of each member. Teams with at least 2 members being either licensed engineers, architects and/or interior designers shall be assigned under the Group B category. All others will be included as part of the Group A category.
3. The following are not allowed to join the Competition:
 - a. Officers and employees of Urban Land Institute Philippines
 - b. Judges of the competition
 - c. Relatives of a and b within the third degree of consanguinity or affinity

THE CONTEST

1. The Competition will commence on 20 September 2022 and end on 24 November 2022.

- 3. Teams will be officially recognized through an email sent by the philippines@uli.org on or before 6 October 2022. The Group category and official registration number of the Team will be sent together with the recognition email.
- 4. Teams who fail to pre-register within the deadline indicated above or did not receive any formal acknowledgement email from Urban Land Institute Women’s Leadership Initiative (“ULI-WLI”) may not submit their entries for the Competition proper.
- 5. Entries should adhere to the following guidelines:

- a. Entries must be submitted on or before 28 October 2022 through the online platform.
- b. Only 1 entry will be accepted and recognized for each Team. Submissions beyond the maximum entries allowable will be disregarded. ULI-WLI will only consider the first entry received as indicated below.
- c. Entries must be submitted in the following format:

Narratives, Design Visions and Detailed Conceptual Phase Drawings in PDF format (A3 size) articulating an outline as such:

Introduction and Rationale
Design Story and Approach
Conceptual Design
Detailed Drawings

A maximum of 20 pages articulating the entire submission is to be accepted.

Drawings must be in CAD and drawn to scale.

All images must have author's copyrights.

All submissions must allow the competition organizers to print and utilize the design appropriately.

- d. Entries must be reasonably accessible and viewable by the Judges to be considered valid and eligible to win the prizes.
- e. Identifying marks such as date stamp, copyright, watermark, or signatures are not allowed.
- f. Entry must not contain inappropriate content, including but not limited to:
 - i. Obscene, pornographic, or sexually-explicit content or

information

- ii. Materials which contain information that poses a risk to the health and safety of others
 - iii. Materials which show strong support or opposition to any political or religious group or person
 - iv. Content that is considered offensive to the users, such as those that encourage the commission of an illegal, immoral or threatening activity, promote harassment, racism, hatred or discrimination against any group or individual, or provide information which you know are false, misleading, or harmful to any group or individual
 - v. Materials which infringe upon the right of any third party, including copyright, publication right, or any other intellectual property or proprietary right, or those which promote the infringement of any party's intellectual property rights
- g. ULI-WLI reserves the absolute discretion to disqualify and/or not to award any prize to any entry which do not meet the criteria and quality indicated above.
6. Upon receipt of the entry, a confirmation email will be sent by ULI-WLI indicating the date and time of receipt thereof. An entry is not considered submitted until such confirmation email is sent by ULI-WLI.
7. In the event that an entry is submitted within the deadline but no confirmation email is received, the team may contact philippines@uli.org for confirmation / clarification.
8. Entries received by ULI-WLI after the deadline set shall not be eligible to win the prizes.
9. ULI-WLI shall not be responsible for any loss, damage, or in the improper or delay or failure in uploading of the entries as well as any technical problem that may arise during the course of the Competition.
10. Each team member recognizes that the entries submitted may be further developed and/or used by ULI-WLI or National Parks Development

Committee. Neither ULI-WLI or National Parks Development Committee has any intellectual property obligation with respect to the entries other than recognizing the names of the team members as part of the concept designers for the project.

11. ULI-WLI reserves the right to disqualify any entry submitted which it deems is in violation of the contest rules.

WHAT IS THE JUDGING PROCESS?

1. Criteria for judging shall be as follows:

Adherence to the design guidelines	40%
Creativity	30%
<u>Innovative ideas</u>	<u>30%</u>
Total	100%

2. At the end of the submission period, all qualified entries shall be collated and scored by the Judges based on the criteria mentioned above.
3. Each Group will be assessed and judged separately.
4. Entries garnering the highest scores will be declared winners and shall be entitled to receive the following prizes:

First Prize: PHP250,000 worth of cash and prizes and a recognition plaque at the national park

One year ULI associate membership for the members

Runner-Up: PHP150,000 worth of cash and prizes

One year ULI associate membership for the team lead

Third Place: PHP100,000 worth of cash and prizes

5. All prizes will be shared among the members of the team. ULI-WLI

does not hold any responsibility as to the agreed sharing amount team members, nor the actual remittance thereof to the team member/s.

6. Winners will be announced on 24 November 2022 at the National Parks Congress. Winners will likewise be notified via email through their Official Team Representative beforehand.
7. Decision of ULI-WLI shall be final and cannot be contested.
8. Information about the judging process and points received by each entry shall be confidential and cannot be revealed at any time and for any reason.

HOW ARE PRIZES CLAIMED?

1. Winners shall be required to present proof of identification when claiming the prizes.
2. Prizes must be claimed within thirty (30) days from announcement. Prizes not claimed within the said period shall be considered waived.
3. Prizes are not transferrable.
4. The winners shall be responsible for all incidental expenses including any taxes that may be applicable for redemption of prizes.
5. In redeeming the prizes, the winners may be required to sign legal documents, including but not limited to release and indemnity forms.

ANY OTHER IMPORTANT INFO?

1. By participating in the contest, each team member confirms, agrees to, acknowledges, represents and warrants that:
 - a. He/she has read and fully understands the Competition rules and agree/s to abide by the same.
 - b. Entry submitted is an original work created solely by the team for

this Competition and no other party has any right, title, claim or interest in the entry.

- c. Entry has not been submitted nor will it be submitted in any other contest or utilized for any project, whether for consideration or for free.
 - d. Entry does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity.
 - e. All personal information supplied may be used and processed by ULI-WLI or National Parks Development Committee without violation of the Data Privacy Act.
 - g. ULI-WLI has the right to validate the information submitted by the teams, including, when it deems necessary, requesting for additional documents from the teams.
 - h. ULI-WLI has the right to identify, communicate and use the participant/s and entries in the Competition through any multimedia release. Each team member may likewise be required to participate in a photo or video shot or an interview which may be used by ULI-WLU for any media release worldwide, including magazines, online, press, tv and other promotional materials, without any payment to the team members.
 - i. Each member of the teams holds ULI-WLI free and harmless from any and all claims, suits and actions for damages or liabilities that may be brought about in connection with their participation in this Competition.
 - j. ULI-WLI shall not be responsible for any associated costs incurred by any of the teams for entering the Competition.
 - k. ULI-WLI shall not be liable for any unauthorized use, reproduction and adaptations by third parties of any material or information regarding this Competition.
3. ULI-WLI reserves the right to modify the Competition rules, to be announced as it may deem necessary. Changes cannot be contested and shall be considered in full force and effect.

4. ULI-WLI reserves the right to cancel, discontinue or suspend the Competition on the basis of force majeure or for any other reason in its sole and absolute discretion.
