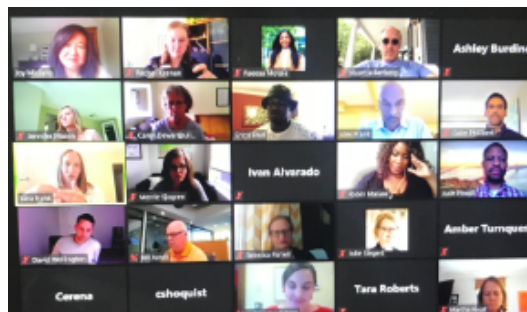


THIS WEEK AT ULI MN...
