

## ULI New York COVID-19 In-Person Events and Meetings Policies

ULI New York plans to resume in-person events and meetings in the fall of 2021

## **VACCINATION POLICY FOR ULI NEW YORK IN-PERSON EVENTS AND MEETINGS**

Throughout the pandemic our primary concern has always been the health and safety of our employees, members and guests and their families. As we prepare to resume in-person events and meetings this fall, and in view of the emergence of the Delta variant, we believe the safest environment in which to convene our employees, members and guests is one in which all attendees are fully vaccinated (those people who are 14 days beyond their final COVID-19 vaccine).

Until further notice, ULI NY will require all attendees of its in-person events and meetings, regardless of the location, to present proof of vaccination upon arrival to the event or meeting in order to participate in-person. **Acceptable forms of vaccination proof include, but are not limited to, the following:** 

- Your official Centers for Disease Control and Prevention (CDC) COVID-19 Vaccination Record Card
- The digital **New York State Excelsior Pass** app, available for free at the App Store or Google Play.
- The digital **NYC COVID SAFE** app, available for free at the App Store or Google Play.

Those unable to provide proof of vaccination, regardless of vaccination status, will not be admitted to the ULI NY event or meeting. ULI NY reserves the right to refuse entry to any visitor. When possible, events and meetings will include a virtual option.

ULI NY has adopted this policy as a necessary protocol to help prevent community transmission of the COVID-19 virus, and any associated variants, and help safeguard the health of its employees, members and guests and their families. This policy complies with all applicable federal, state, and local laws and is based on guidance from the Centers for Disease Control and Prevention (CDC) and state and local public health authorities, as applicable.

## MASK POLICY FOR ULI NEW YOK IN-PERSON EVENTS AND MEETINGS

In accordance with the <u>CDC's Interim Public Health Recommendations for Fully Vaccinated People</u>, issued July 27, 2021, ULI NY strongly recommends fully vaccinated event or meeting attendees (those people who are 14 days beyond their final COVID-19 vaccine) wear a mask in public indoor settings, such as conference rooms, event spaces, networking areas, restrooms and hallways, until New York City is no longer considered an <u>area of substantial or high transmission</u>.

ULI NY will continue to monitor the public health guidelines per the CDC, New York State and New York City public health authorities. ULI NY reserves the right to adjust and change its policies and procedures to be compliant with any changes in public health guidelines or to comply with any additional public health measures required by the host venue and will communicate any such changes to event or meeting participants accordingly.

## WAIVER AND RELEASE FOR ALL EVENTS AND MEETINGS

I understand that my participation in the Event or Meeting involves a certain degree of risk of loss, harm or injury to my person or property, including, but not limited to, harm from contracting COVID-19 or other viruses, acts of God, theft, fire or accident. I also understand that participation in this Event or Meeting is entirely voluntary and requires attendees to abide by any applicable rules of conduct or local or state laws that may be announced at any time during the Event or Meeting, which may include wearing personal protective gear and engaging in social distancing. While ULI NY is the sponsor of this Event or Meeting and takes commercially reasonable steps to require the Event or Meeting facility to maintain the venue in a safe and healthy condition, I understand and acknowledge that ULI NY has no direct control over and is not responsible for the acts or omissions of the facility or others involved in producing this Event or Meeting. I have carefully considered the risk involved and waive and release ULI NY and all its officers, directors, employees, staff, volunteers, faculty, and affiliates from any and all claims, damages, injuries, or expenses that I may incur from my participation in this Event or Meeting.
