

## 2023 ULI NEW YORK AWARDS *for* EXCELLENCE *in* DEVELOPMENT

A guiding principle of the Urban Land Institute is that the achievement of excellence in land use practice should be recognized and rewarded. ULI has been celebrating excellence in development internationally since 1979 through its Global Awards for Excellence, the development industry's most prestigious awards program. The ULI New York Awards for Excellence in Development embody that same principle and seek to recognize outstanding real estate development projects within the New York District Council's geographic region, both in the private and public sector, that exemplify ULI's mission to shape the future of the built environment for transformative impact in communities worldwide. The ULI New York Awards for Excellence recognize the full development process of a project, including its architecture and design. Projects that reflect best-in-class development may be submitted for an award in the following categories: office development, market-rate housing development, affordable housing development, mixed-use development, adaptive reuse, hotel development, institutional development, civic development and urban open space.

**The ULI New York Awards for Excellence are open to the entire industry, not only ULI members. Private sector, public sector, and nonprofit projects located anywhere in New York State are eligible to submit, except for projects in Westchester County which is part of ULI Westchester/Fairfield.** All applications will be evaluated by a distinguished jury panel of ULI members, representing all major segments of our industry. The jury will consider how a development demonstrates leadership, innovation, market success, sustainability, resiliency, and meets the current and future needs of its surrounding community.

## AWARDS CATEGORIES

---

Projects can be submitted in the following categories:

- **Excellence in Office Development**
- **Excellence in Market-Rate Housing Development** (defined as any residential project in which 30% or less of the for-sale or rental units are income restricted)
- **Excellence in Affordable Housing Development** (defined as any residential project in which more than 30% of the for-sale or rental units are income restricted)
- **Excellence in Mixed-Use Development** (two or more materially different uses, where each use accounts for 20% or more of the project's rentable square footage)
- **Excellence in Adaptive Reuse** (defined as the redesign and alteration of an existing building for a purpose other than that for which it was originally designed or built)
- **Excellence in Hotel Development**
- **Excellence in Institutional Development** (includes hospitals, educational facilities, and cultural facilities)
- **Excellence in Civic Development** (includes public infrastructure, transportation facilities, public buildings, etc.)
- **Excellence in Urban Open Space** (includes parks, plazas, greenways, privately owned public spaces, etc. that are open and inviting to the public)

**Please Note:** Redevelopment projects are eligible to be submitted and will be evaluated based on their property type (e.g., office, affordable housing, etc.).

## SELECTION CRITERIA

---

- The project must reflect innovation in planning and design
- The project must exhibit environmental sustainability, stewardship, and resiliency
- The project has achieved broad acceptance in the marketplace **(this criterion counts for 25% of a project's overall score, except for projects nominated in the Affordable Housing Development, Civic Development and Urban Open Space categories)**
- The project must provide lessons, strategies, and techniques that can be adapted in other communities **(this criterion counts for 25% of a project's overall score for projects nominated in the Institutional Development and Affordable Housing Development categories)**
- The project must be substantially complete on or after **January 1, 2018**, and before **February 13, 2023**. "Substantially complete" means a single-phase project must be finished, occupied, and in operation within the completion window. For multiple-phase projects, at least the first phase must be finished, occupied, and in operation within the completion window.
- The project must make a significant contribution to promoting land use for the betterment of the community
- The project must demonstrate relevance to the contemporary and future needs of the community in which it is located **(this criterion counts for 25% of a project's overall score for projects nominated in the Affordable Housing Development category)**

Please submit this application as **a locked PDF**. **Applications submitted in any other format will not be accepted.** Supplemental materials will not be accepted unless asked for by ULI staff. Your responses for **Reasons for Consideration, Project Description, and Challenges and Obstacles** must comply with the word/character limit indicated. Complete application packets must be received by **5:00pm Eastern Time on March 24, 2023**. Submissions that are incomplete and/or do not follow the submission guidelines and requirements will not be considered.

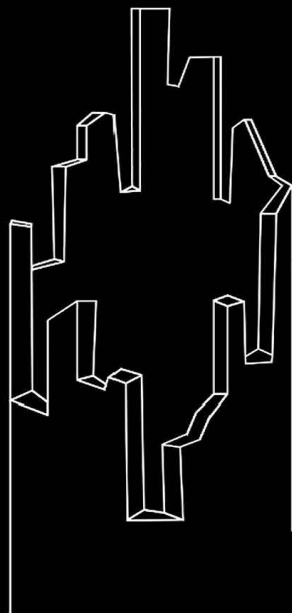
